3. Insurance, Road Tax, Fitness, Road Permit, Speed Governor be up-to-date.
4. Buses must have internal facility and staff uniform etc. as per guidelines of the Apex Court and instructions of District Administration.
5. Every bus must have a Driver with appropriate Driving License and one Khalasi (Cleaner/Helper).
6. Hire charges will be paid for 11 (Eleven) months only.
7. The agreement will be finalized for the period of 11 (Eleven) months from 01/07/2019.
8. For any indiscipline or undesired activities the agreement will be terminated with one month notice or payment in lieu of that.
9. The buses must be fuel efficient & fuel will be paid as per GPS reading of the distance.
10. The Base Rate be quoted inclusive of all the expenses except fuel (Diesel).
11. Quotations will be accepted only in the format spread on the School's Website & Notice Board.
12. Sealed quotations be sent to the Principal "DAV Public School, Manpur, Gaya" within 10 days of this advertisement either by Registered Post or by hand to the office.
